8.1 SUPERINTENDENT'S REPORT

8.1.1 STRATEGIC PLAN DEVELOPMENT TIMELINE

The Board was informed that the District is in the process of beginning the next four year Strategic Plan. The following emerging District Initiatives were provided: two education goals (Successful Transitions and Literacy); focus on children in care and Aboriginal Students; Action Plans for Learning; Admin Growth Plans; Redesigned curriculum/ curricular core competencies; communicating student learning; Early Learning; modernization of facilities; District risk assessment; Middle school transition; Human Dignity Coalition; and, the IDEA Summit.

The timeline for the development of the new Strategic Plan is as follows:

January to March 2019 – Consultation with Partner Groups and Community

April 30, 2019 – Final draft to Trustees for approval at the April Regular Board meeting

May 2019 – Community Partners' Luncheon

8.1.2 ENGLISH LANGUAGE LEARNERS (ELL) DEPARTMENT / SETTLEMENT WORKERS IN SCHOOLS (SWIS) PROGRAM UPDATE

The Board received an update from District Principal of ELL/SWIS, Karen Beatty, on the English Language Learners and Settlement Workers in Schools (SWIS) program.

Data was provided on the District's ELL students which reflects 78 different language groups and shows a significant increase since 2012. A breakdown was also provided on where these students attend school and who makes up the ELL student numbers. Many of these students have a variety of other issues they struggle with including mental health issues and culture shock.

The new District Principal of ELL/SWIS, Joanne Neveux, was also introduced to the Board.

The Ministry's funding announcement is done in March, which is when school districts receive notice of their funding for the next year.

The status quo budget expenditures and revenues were reviewed, as well as the process followed to determine enrolment projections for the 2019/2020 school year.

9.2 INFORMATION ITEMS

9.2.1 FINAL ENROLMENT REPORT

The Board was informed that the final enrolment numbers have been submitted to the Ministry and these numbers will form the resulting funding announcement by the Ministry in December. The headcount and FTE change was provided, along with a comparison of the September numbers between 2017 and 2018.

9.2.2 ENROLMENT REPORT - FUNDING UPDATE

The Board reviewed the increases and decreases in the various funding categories.

9.2.3 ENROLMENT REPORT BY CATCHMENT

The Board reviewed the enrolment by catchment by region, with the RE Mountain catchment showing the most growth over last year.

There was a decrease in enrolment in Aldergrove Community Secondary, Langley Secondary, Walnut Grove Secondary and Brookswood Secondary catchments.

The enrolment in Choice programs has declined by 33 students this year.

Total school-aged headcount by school levels was provided. Enrolment at the Middle school level has remained constant.
