SUBJECT:	Five-Year Capital Plan (Minor Capital Programs) 2025/2026

RECOMMENDED MOTION:

In accordance with provisions under Section 142 (4) of the School Act, the Board of Education of School District No. 35 (Langley) hereby approves the proposed Capital Plan (Minor Capital Programs) for 2025/2026, as provided on the Capital Plan Summary for 2025/2026 submitted to the Ministry of Education and Child Care.

BACKGROUND:

The Ministry of Education and Child Care requires school districts to submit annually a Five-Year Capital Plan. This is done in two phases with the first phase for Major Capital Programs that the Board approved at the June 18, 2024 Board Meeting and the second phase, which is due September 30th for Minor Capital Programs. The Minor Capital Programs summary is attached and is being brought to the Board for approval.
